- **Classical guitar, electric/bass guitar, violin/viola and percussion:** students are expected to provide these instruments for themselves from the beginning.
- **Cello:** students studying these may borrow a IMSS instrument for a maximum of two years.
- **Oboe, bassoon, double bass, harp, euphonium, tuba and horn:** students studying these may use a IMSS instrument for the entire period of learning.

1. I fully understand that the instrument is available on loan **for a yearly hire fee** and that I need to purchase or obtain privately a suitable instrument when the periods of loan expire.
2. I will pay the school **\$110** (there is no GST charged) for the hire of the instrument for this year (_) which also covers the costs of depreciation, maintenance and repair if needed to the instrument. This amount is non-refundable.
3. I understand that damage or loss caused by an accident, deliberate act or negligence on the part of me or my child/ward is my responsibility and I may be asked to meet the costs of such damage or loss. This may include replacement of accessories supplied.
Note: It is recommended that parents make appropriate independent insurance arrangements to cover this possibility
4. I understand that the loan is contingent on my child being a full participant in the instrumental music program at this school and the instrument will be returned immediately upon request should we leave the school and/or the program.

Periods of loans:

- Flute, clarinet, alto saxophone, trumpet, trombone: **one school year only**
- Cello: **two school years only**
- Euphonium (or baritone), tuba, french horn, double bass, oboe or bassoon: **for the duration of study at the above nominated school.**
